## **Shared Solutions Professional Development Training Materials**

In order to build on the momentum of *Shared Solutions: A Guide to Preventing and Resolving Conflicts regarding Programs and Services for Students with Special Education Needs* in contributing to the prevention and resolution of conflicts in school boards, the Ministry of Education has compiled all the training materials from the 2007 regional professional development sessions, including video of the speakers and a parent/student video, onto a CD-ROM/DVD.
