#### 1. SEAC Planning

This is the time for SEACs to plan their meetings for the coming year, so I have attached a revised PAAC on SEAC calendar, outlining, month by month, the items that you should consider for your agendas.

#### 2. OPA Assessment Project

On October 15<sup>th</sup> a few representatives from your board should be attending a conference, *Sharing Promising Practices*, showcasing outcomes of the Ontario Psychological Association (OPA) Student Assessment Project. A *Promising Practices* Guide will also be released at that time. <u>Ask for a presentation to your SEAC on this conference and for a copy of the *Promising Practices* guide</u>

#### 3. Education for All

As mentioned in the June SEAC Circular, consultations took place on the expansion and revision of *Education for All* to a new K to 12 Ministry of Education resource document. A writing team has been working over the summer on a preliminary draft, and the final version should be released early in 2009. Regional training sessions will follow the release.

#### 4. Dedicated PA day

In April 2008 a memo was sent to Directors of Education strongly recommending that boards devote one of the six 2008-09 PA days to special education issues. Most boards have chosen to use a date in the 2009 portion of the year, and the Ministry is encouraging them to focus on IEPs and to use the materials to be released around the revision of Education for All. <u>SEACs should ask to be included in the planning of the special education PA day</u>. A presentation on the role of SEAC could be offered as part of the training, or some materials on SEAC's role could be distributed.

#### 5. IEP Initiatives

Over the summer the Ministry has been developing sample IEPs for students with a range of special education needs, in both elementary and secondary settings. School boards had been asked to send in anonymous samples, and a team of knowledgeable educators used these samples and sharing of their own experience to write a set of samples that reflect all exceptionalities. The first set of these will be sent to boards and then posted electronically, in time for IEP season. The plan is for parents to have access as well. The samples are a work in progress, and there will be additions and changes with time. <u>SEACs should ask to see the Memo to Directors that announces the IEP Samples when it comes out.</u>

LDAO and the parent associations on the Reference Committee continue to work on producing the content for the Ministry-funded *IEP Resource for Parents and Students*. This project, with will create an online training resource, is slated for completion by the end of March 2009,

#### 6. CODE Projects

The professional development projects funded through the Council of Ontario Directors of Education (CODE) have finished their funding cycle. A research report will be posted in November on the CODE website (<u>www.ontariodirectors.ca</u>). There will also be a *CODE "Education for All" Leadership Summit* on November 17 & 18, 2008. Boards will be able to send a small number of delegates, which may include SEAC members. <u>Ask if your board plans to send a SEAC member</u>.

#### 7. EQAO Results

The Education Quality & Accountability Office (EQAO) has released summaries of results of provincial assessments in 2007-08 for Grades 3, 6 and 9. A summary for all students, and charts for students with special education needs are attached.
