Kawartha Pine Ridge District School Board Ends Our 8-Year Partnership

The long-term funding partnership with the Kawartha Pine Ridge District School Board has ended. With the ever growing numbers and needs of our Special Education students, our local school board must redirect these dollars to enhance the in-school supports provided to their students. “We applaud the KPRDSB for its commitment to their students, but in relation to our specialized programming, it is a blow.” Shari Davis, the Learning Disabilities of Peterborough’s Executive Director states. The impact of the news will be felt by families in the region with school-aged children who have Learning Disabilities, ADHD, and general learning challenges.

“We are deeply saddened to learn that over 450 families with children struggling with LDs and ADHD will no longer have free access to our Specialized Tutoring programs.” says Davis.

Through the Association’s programs, students receive one-to-one specialized tutoring utilizing assistive technologies to support learning success. The programming is unique within the region, and has welcomed thousands of students over the 8-year partnership. “More and more we are seeing families struggle to pay our fees, even though those fees are set very low. For-profit companies charge significantly more, and do not offer the one-to-one services.” commented Davis.

Without the partnership dollars, families must now pay full fees. Davis is afraid that many families will opt out because of the state of the economy. “Throughout the term of the partnership we saw a lot of single parent families, grandparents on fixed incomes raising grandchildren, unemployed and underemployed parents. These are the families I worry about. For many it’s a choice between paying bills and tutoring. What a choice.” continued Davis. “That was the beauty of the partnership, it meant families within the public school system had access to the tutoring and the kids were helped, no matter the family financial condition.”

Applications Series – No.1

“Applications & Choice”

This is the first in a series about the many applications or apps that are available for your android or Apple products, and how they can help those with LDs and ADHD. Michael Kerr presented this information in a series of workshops earlier in the year, and has given us permission to set them out here.

The following is a brief summary of apps for Android and Apple that can assist learning. It is important to remember to find the tools and applications that work best for you. Not everyone will connect with all applications – find what works for you and expand from there. There are new applications created every day and existing apps are revised many times a year. Always check back and keep looking for the best tools to support your learning.

There are many apps that can help you search for apps such as AppShopper, Appolicious, Discover Apps and AppZapp. Remember to look at the app ratings and reviews, although reviews do not mean an app is for you they will give you a guide to how many people like an app. Search regularly for apps. Sometimes the offerings can change dramatically even in a week. Follow sites such as Edutopis and Learning Disabilities networks for educational ideas for learning with technology.

You read earlier about the Public School Board withdrawing all funding support for parents who want their child to receive tutoring in our after-school program. My worry when they told us in August was that we would see a plunge in registrations because parents would opt out. Even though the cost is currently \$225.00 for 8 weeks, many families cannot afford even this low fee. My ‘whew’ came when some parents did sign up, and we were still able, through other sources, to help some lower income families.

Whew #3

A third ‘whew’ came when I saw how the staff and volunteers rallied round and took reductions in hours to save costs, stepped in to help when others needed assistance, developed a plan to see us through immediate challenges, and did all they could and can to ensure the Agency continues! It is quite a dedicated team I have here.

So I have been through all the stages of ‘whew’ in the last few months – surprise, relief (big time), tiredness, and yes, sometimes hot! But the challenges that have been presented are part of the ebb and flow of any charity or business. I am hopeful the challenges will abate, and soon. I’d like to get my blood pressure back to normal and give a big ‘WHEW’ when it does.

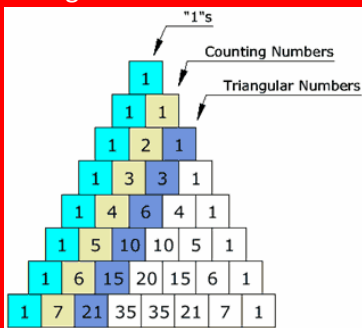

TIPS TO KEEP YOUR CHILD LEARNING DURING THE HOLIDAYS...

If you celebrate Christmas, or even if you do not, you can help your child develop many skills using these fun exercises.

1. Tracking Santa's big trip is a great exercise in geography, distance, speed, temperature, & time zones. You can track Santa with the help of NORAD – www.noradsanta.org
2. Take your favourite recipe & double it, or convert it to metric, or use only a teaspoon & $\frac{1}{4}$ cup to measure. How long does it take to cook a turkey measured in seconds?
3. Have your kids develop a budget & stick to it! In the end, compare the actual expenditures with the budget. How did they do? Bonus points for anyone that spends less!
4. Using the song, the Twelve Days of Christmas, figure how many gifts in all are given in the song. Try using Pascal's Triangle to find out.



By the way, what would you prefer... the twelve gifts or \$1.00 doubled for 12 days? How about \$12.00 each day for 12 days?

5. Make your own Christmas calendar & count down the days! Have older children include minutes & seconds.

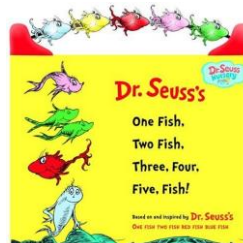
Building Essential Skills: Numeracy & Math

Helping your young child build numeracy & math skills early means you are establishing the foundation of an essential life skill. Using hands-on activities, problem-solving play, communication, & ordinary life connections allow for different learning styles & help them understand the fundamentals. Our staff came up with this list to make learning fun.

- ✚ Play games that require your child to name numbers and use sequencing and counting skills e.g. a "number hunt" in your neighbourhood.
- ✚ Have your child estimate and compare the size and weight of various household objects e.g. what is bigger a grapefruit or a softball? Which is heavier?
- ✚ Give your child a newspaper or magazine and ask them to look for the numbers that will make a series e.g. 1 to 25 or 1 to 100 if they know larger numbers. Have them cut out the numbers and glue them in sequence to a piece of paper.



- ✚ Sing counting songs. "One, Two, Buckle My Shoe" can make learning to count – both backwards and forwards – fun.
- ✚ Use household items to practice adding, subtracting, and for older children, multiplying and dividing e.g. how many wedges are in your grapefruit? If you eat one, how many are left?
- ✚ Count everything! Count toys when cleaning up, count forks and knives when setting the table, count clothes coming out of the dryer or off the clothesline! Count.
- ✚ Read counting books!! There are lots of them out there! Think of old reliable, Dr. Seuss.



Ministry of Education: Updated Definition for Learning Disabilities

In August the *Ministry of Education* released a Policy Memorandum which defines “...Learning Disability as one of a number of neurodevelopmental disorders that persistently and significantly has an impact on the ability to learn and use academic and other skills that:

- *Affects the ability to perceive or process verbal or non-verbal information in an effective and accurate manner in students who have assessed intellectual ability that are at least in the average range;*
- *Results in (a) academic underachievement that is inconsistent with the intellectual abilities of the student (which are at least in the average range), and/or academic achievement that can be maintained by the student only with extremely high levels of effort and/or with additional support;*
- *Results in difficulties in the development and use of skills in one or more of the following areas:*
 - *Reading*
 - *Writing*
 - *Mathematics*
 - *Work habits*
 - *Learning skills;*
- *May typically be associated with difficulties in one or more cognitive processes such as phonological processing, memory and attention, processing speed; perceptual-motor processing; visual-spatial processing; executive functions (e.g. self-regulation of behaviour and emotions, planning, organizing thoughts and activities, prioritizing, decision-making);*
- *May be associated with difficulties in social interaction (e.g. difficulty in understanding social norms or the point of view of others); with various other conditions or disorders, diagnosed or undiagnosed; or with other exceptionalities;*
- *Is not the result of a lack of acuity in hearing and/or vision that has not been corrected; intellectual disabilities; socio-economic factors; cultural differences; lack of proficiency in the language of instruction; lack of motivation or effort; gaps in school attendance or inadequate opportunity to benefit from instruction.”*

This is a comprehension definition which acknowledges the complexity of the disability, but in shorter parlance, LDs influence the ability of the individual to acquire, retain, understand, organize and utilize both verbal and non-verbal information. Learning Disabilities are complex, but solutions are available.
